The Judith Campbell Scholarship is awarded annually to graduating high school seniors who plan to continue their education at a four year college or university, a community college or trade/technical school. Applicants must be attending a high school in San Diego County at the time of application and have a minimum GPA of 2.75. The purpose of the scholarship is to financially assist deserving students who might not be able to attend college due to financial constraints. Applicants will be evaluated on the following criteria:

- 1) Meaningful student essay, demonstrating ability to overcome personal obstacles, as well as a strong commitment to continuing personal growth and development through higher education
- 2) Demonstrated financial need
- 3) Academic standing and/or the potential for success
- 4) Engagement in their community through involvement in extra-curricular, community service and/or work activities
- 5) At least one letter of Recommendation. Appropriate recommenders include:
 - a. High school teacher, counselor, coach or school administrator
 - b. Employer
 - c. Staff where student volunteers or interns
